Zone Maps and Economic Revitalization Zoning (ERZ)

Tom Morgan, Town Planner presented to the board new maps for the purpose of the Economic Revitalization Zones. This is an adjustment so more property owners can take advantage of the ERZ credit which is a tax break from the state for commercial and industrial zones, which they're total of 23 zones in the state and Seabrook is one of the. Most of Seabrook's applicants and property owners aren't aware of the ERZ credit and the board members discussed that we need to promote and educate the town more regarding this program. In Seabrook, Industrial Zone 3, Commercial Zone 2 excluding Route 286 and Zone 6M excluding Smithtown would benefit the most from this credit. The board held a discussion regarding the pros and cons excluding Smithtown and Route 286, and came to the conclusion that it would be better off excluding them.

Morgan stated that changing this requirement will allow the contractors/engineers figure out how many parking spots they need rather than having too many, which is currently the issue within the town.
