Mr. Khan asked that Mr. Manzi give some information on the vehicle that is being surplused. The truck has no useful life left for the water department. The water superintendent has made the recommendation to surplus and he agrees. Mr. Khan asked if a copy of the memo could be sent to the budget committee. Mr. Manzi said the updated auto inventory list would be completed this week and given to the board and committee but he will give them the memo as well.

QUESTIONS/COMMENTS

Mrs. Kyle said the beach access paths are supposed to be 20-feet wide and some are only 4-feet. She would like this looked into as well as the one path that has a sprinkler system located within the town right-of-way. Mrs. Kyle said that someone was mowing the dune grass this weekend. With all of this and with the incident that happened this summer these should all be looked at for safety measures. Mrs. Brown agrees with this and said something should be done.

Mrs. Kyle said she would like to know the process of getting permits and would like to have a meeting with the planning board so they know what the law and ordinance are for the town. She feels they should be enforcing the violation of wetlands.

Mr. Khan said they had met with the Army Corp of Engineers last week and they have a letter to be sent. Mr. Khan read the letter into the record (see attached). This letter will not hold up the dredging.

Mr. Manzi gave an update on the bridge meeting. There are some engineering decisions to be made as it is still an early project. There will be more to come as the project progresses. Mr. Khan said the next meeting will be in December and there will be more information available. It is estimated to be about 6 years out in 2024.

Joe Guiffre said there was another committee at this meeting and he would like to know what their job is in this project. Mr. Manzi said that the committee included the harbormaster and individuals that were contacted based on a list provided by him when they initially came into discuss the project.
