Mrs. Kyle said she also attended the recreation commission meeting and they are looking for security cameras for the building. She said they desperately need them and it comes down to cost. Mr. Manzi said the cost is between \$10K-20K. It was asked if it would be proper to take the money from the D'Alessandro fund. Mr. Manzi said if the board would like to do that it should not be an issue. He said he would give the board a memo with the actual quote. Mr. Manzi said they do have a system but it is antiquated. He said after they get the memo with the exact cost they can then order it come from D'Alessandro. There is a lot of activity in this building and it is important to have the cameras for security measures.

Mr. Khan said he would like to bring in the individuals who worked on the playground at Veteran's Park to recognize them. Mrs. Kyle said DPW also did a lot of work at this park. Mr. Manzi said it was terrific work with everyone working together and the children are the beneficiaries of this beautiful park.

Mr. Manzi thanked Geno Marconi for bringing the meeting on the bridge to Seabrook as well as Mike Pike who was in attendance.
