**Jim Sanborn opens the meeting at 6:30 pm with the pledge of allegiance.**

**Mr. Chairman is looking for a motion to accept the meeting minutes from the last meeting, 12/19/19.**

**Mr. Chairman** opens the public meeting for discussion on the proposed revisions from sections 2 and 6. Any comment.

**Rabideau** states that he has submitted the article on apart-hotels and would like some feedback from Tom Morgan on that.

**Morgan** rereads the definition of hotels from the zoning ordinance and doesn't think that they will come into any issues with that.

**Morgan** recaps from the last meeting on the proposed changes from sections 2 and 6. Tom states that tonight the board either makes additional revisions or doesn't accept any of the proposed revisions.

**Sanborn** opens it up to the public for discussion.

**Jeff Brown** of 118 Railroad Ave would like to speak as he has many questions on the proposed revisions. He would like know if a dwelling unit will now include ADU. Would an in-law? He is asking what the definition of a transient person is and how this will affect the people that rent houses in town month to month or even the people that rent for 6 months at a time.

**Tom Morgan** reads the definition of a transient person.

**Selectmen Theresa Kyle** wishes that the definitions were made much clearer so there could be some distinguishing between the wording.

**Rabideau** would like to know if there are any regulations on the number of people.

**Gail Beckman** from 12 Walton Rd. states that there is going to be more and more of these transitional homes popping up. She states that there is no limit on the number of people allowed in a house.

**Henry Boyd** speaks about the housing situation. He is sad that more of the residents haven't gotten involved with this issue. He states that everyone brings different outlooks to the table. He suggests setting up the zoning to something that isn't discriminatory.

**Khan** feels that the board needs to work on this as a committee and then revisit these issues and make something better for the residents.

**Kyle** agrees with Khan and feels that the board needs to do some research and then make a decision.

**Khan** thinks they should make up a committee with 5 people from each board and work on this.

<b>Motion:</b> <b>Rabideau</b>	<b>Section to include the dwelling unit and alterations as shown: Eliminates House guest or rooming paragraph, Eliminates boarding house, rooming house, guest house, group home paragraph and Bed and breakfast inn paragraph and eliminates short term rentals paragraph but includes uses that are not permitted or designated as right. Also eliminates the chart on the zoning district.</b>

**Khan** asks **Mr. Morgan** what will happen if the above motion is passed. Morgan states that the Air B and B's will be prohibited.

**Tom Morgan** says he will write up an amendment to the bylaws for 2/4.

\*The board discusses how they would like to go about board members not showing up for the meetings. Some ideas were: 3 consecutive, unexcused, absents and the member will be voted off. Sanborn liked the idea of using a percentage of meetings missed. The board will discuss at a later time.
