PURPOSE OF PROPOSAL

The purpose of this Invitation to Bid and accompanying specifications are to provide proposals for the Equipping a Newly Purchased Cab and Chassis with Plow Equipment and Dump Body per the attached Specifications or equal provided by the Department of Public Works Manager, John M. Starkey. The successful vendor awarded this contract will at their place of business, on delivery of the new International Cab and Chassis Truck, commence the installation of those items provided in their bid and that all labor and incidentals associated with this installation will be at no additional cost to the Town of Seabrook.

PROPOSAL TERMS

The Town of Seabrook reserves the right to accept or reject any and all proposals in whole or in part received as a result of this IFB. If a proposal is selected, it will be the most advantageous regarding price, quality of service, the contractor's qualifications and capabilities to provide a particular service. The Town reserves the right to consider proposals for modifications at any time before a contract be awarded, and negotiations would be undertaken with that contractor whose proposal is deemed to meet the Town's specifications and needs best. There will be no reimbursement to any candidate if the selection process is terminated. The Town of Seabrook reserves the right to waive defects and informalities of the proposals.

All bids must be received no later than 2:00 pm EST on November 18th, 2021. The submittal package shall include three (3) copies of the proposal. No telephone, email, or facsimile proposals will be accepted. All proposals received after the deadline will not be accepted and will be returned unopened.

INTENTION TO BID / ADDENDA

Bidders that want to participate in the IFB are urged to submit an intention to bid form to receive addendums and possibly additional information. Intention to Bid forms can be found on the town website at www.Seabrooknh.info/procurement. Completed Intention to Bid forms and questions may be emailed to the Chief Procurement Officer at Swood@seabrooknh.org. All questions shall be submitted in writing to only the Chief Procurement Officer at the above address, a minimum of 7 days prior to the scheduled bid closing. The Chief Procurement Officer will then forward both the question and the Town's response to questions to all prospective bidders. In the event it becomes necessary to revise any part of the IFB, addenda will be provided by email and on the Town website at www.Seabrooknh.info/procurement. WITHDRAWAL OF BID PROPOSAL

A bidder will be permitted to withdraw his/her proposal unopened after it has been deposited if such request is received in writing prior to the time specified for opening the proposals.

CONSIDERATION OF PROPOSALS

Bids will be made public at the time of opening and may be reviewed only after they have been properly recorded. In the case of discrepancy between prices written in words and those written in figures, the prices written in words shall govern. In the event of a discrepancy between the total shown in the proposal and that obtained by adding the products of the quantities of items and bid prices, the latter shall govern.

AWARD OF CONTRACT

The successful bidder will be notified, by mail to the address on his/her proposal, that his/her bid has been accepted and that he/she has been awarded the contract.

CANCELLATION OF AWARD

The Town reserves the right to cancel the award of any contract at any time before the execution of such contract by all parties without any liability against the Town.

EXTRAS

Except as otherwise herein provided, no charge for any extra work or material will be allowed unless the Town Manager has ordered the same, in writing.



SPECIFICATIONS

(Provided by Department of Public Works Manager, John M. Starkey)

Heavy-duty dump body with shuttle door tailgate, front plow hitch, new front plow, wing plow hitch, new wing plow, stainless steel sander, load covering assembly with canvas cover and information on hydraulic pumps and LED working lights.

1. **HEAVY-DUTY FRONT HITCH** will be a TECO **H345-FW ONTARIO** heavy-duty or equal tilting front hitch with tubular steel cross supports, TECO Locs and a front remote.
2. **HEAVY-DUTY FRONT CABLE WING POST** will be a Tenco **FFC52**, 52" cable or equal front wing post with a full trip hinge.
3. **HEAVY-DUTY REAR CABLE WING POST** will be a Tenco **FRC48-R** heavy-duty or equal cable rear post with hydraulic push arm kit.
4. **HEAVY-DUTY 10' WING PLOW BLADE** with a **10' cutting edge and 11' overall length**, will be a Tenco **TCW-10-S-38 7-gauge** wing with a full trip hinge with a steel spring carbide, and cover blade.
5. **HEAVY-DUTY TRIP EDGE FRONT PLOW** will be a Tenco **TCP-11-S-42-E2-HA2**, or equal, three spring trip edge plow with a ten-gauge steel moldboard, quick attach oscillating bar, 12" rubber deflector, carbide, and cover blade.
6. Hydraulic system to include front-mounted **extra-large 80cc load sense pump for exceptional hydraulic performance**, with a low oil override, a Walvoil six-section valve, cable plow, wing and body controls, a Muncie 300 electronic sander control, #304 stainless steel hydraulic tubing to the front, and the rear. Hydraulic quick couplers for all removable attachments, a steel hydraulic tank mounted behind the cab below the window on the frame rails.
7. The lighting system will include **Heated LED headlights; four heated LED work lights** placed on the wing, the spinner, and the two in the rear. The amber warning system will include a **LED Liberty Bar light mounted on a bar on the roof of the cab**, LED amber strobes in the rear corner posts. There will also be LED STT's.
8. **DUMP BODY** will be a **TENCO MDS-10-30-36 ULTRA Heave Duty Body** or equal. The body will include **1/4" AR450 180,000psi Hi-Tensile steel** in the floor and tailgate, **there will be three (3) COAL DOORS** mounted in the six (6) panel tailgate, **3/16" AR250 Hi-Tensile steel** in the sides and front, a **Donovan Bullet electric load cover system** with a mesh tarp, a **ladder with safety grip steps and a handle** mounted on the driver's side, inner body step, a double-acting tailgate with air operated latch system, **an 8" asphalt apron**, a pintle plate with D-Rings, a 20 ton pintle hook, connect glad-hands, two sets of mud flaps with anti-sail brackets on the front pair, **a double-acting under-body scissor hoist, a 30" cab shield**. The body will be **painted black and undercoated**.
9. **STAINLESS STEEL SLIDE IN SPREADER** will be a Tenco **TCD-10-54-AS-304SS** or equal slide in V-Box spreader. The spreader has #304 stainless steel body and stainless-steel screens, a tailgate trunnion and tie-down kit, twin 80-gallon liquid tanks mounted on each side of the spreader, an electric liquid pump in a cabinet, **front and rear custom spill shields as specified, a rear mount ladder as specified and exactly like the ladder on the existing (Truck #54's) spreaders**, a manual crank feed gate.
