Carrie Fowler, Finance Manger said it's because the whole about for the Rockingham Planning Commission membership for about \$9,000 was charged to the town managers budget. Manzi stated that the RPC dues are suppose to be disturbed between certain boards and departments and Fowler will do a journal entry to fix it. There were discussions about who receives the vehicle allowance for the town managers office as he has 6 positions in his budget and 3 people receive the vehicle allowance, questions were asked if they hire a payroll supervisor if they will receive the stipend, Manzi said no because the new SSEA contract has taken out the stipend and is now the \$.58 federal mileage rate.
