#### **220 Police Department**

Chief Brett Walker presented the budget, with the highlights of a 4% increase due to contractual items, and the price energy and fuel prices rapidly rising. There was a discussion held with the committee and Bill Manzi, Town Manager regarding if fuel and energy is considered a contractual item. Manzi expressed he sees them as contractual that the department needs fuel to operate the patrol cars, and heat for the building, along with electric. The committee and Manzi agreed that going forwards gas and electric will be placed under a different category on intro page of the budget.

#### 230 Fire Department

Chief William Edwards was presented his budget to the committee, he stated there has been about a 10% increase, which is about \$611,926. He said that there are 20 full time firefighters and 4 dispatchers, which equal out 5 per a shift, that has been that way since 2003. The 10% increase highlights are due to contractual items and overtime. There was a conversation about overtime and why the amount is so high, Chief Edwards broke it down to the committee, that when they get a call, additional personal has to be called in the cover the station, therefor they are receiving overtime, Edwards stated that for the overtime to go down he would need 4-8 more fire fighters, which has been turned down by the voters in the past.

# Warrant Articles

Bill Manzi presented the 2023 Draft Warrant with the committee. Fire Chief, William Edwards and Police Chief, Brett Walker presented there articles to the committee.

# Article 8 – Fire Department Building Maintenance \$50,000

Chief Edwards said this article is for building maintenance at the fire station which would include, HVAC system, sprinkler system and shower renovations.

#### Article 9 – Fire Department SCBA Gear Fund \$90,000

Chief Edwards explained this is an article that is on the ballot every year, but this past march it was denied, therefor the amount of this article is increased because the fund is getting low.

#### Article 18 – Replace Insulation Apparatus Bay \$100,000

Chief Walker explained this article is to start saving for equipment for 2025, the equipment is tasers, firearms, protective vests and digital equipment for cruisers.

#### <u>Article 23 – Police Department Women's Locker Room \$40,000</u>

Chief Walker stated this article is to renovate the women's locker room, as it has not been updated since constructed in the 1980's.

Chief Walker said this article was on the ballot the past March 2022 and it failed. Most of the HVAC has failed the past two years.
