Total cash in the SBVD checking and saving accounts was \$849,972 at the end of October 2024 vs. \$752,430 at the end of October 2023.

- Current month revenues included \$39,140 fee income and \$1,550 rental income. Expenses were \$3,764 with no unusual expenses in the month. Interest income for the period was \$2,003. The net income was \$38,929.
- The commissioners voted to pay the SBCA invoice for \$1,000 to replace the Maguire family bench destroyed over the winter. The SBCA did not provide the cost documentation requested by the commissioners but after discussing issue they voted 2 to 1 to approve the invoice. Hawkins and Corde voting Yes and David voting No.
- Ed David provided an initial budget estimate for 2025 for the commissioners to discuss at the December meeting.
