Chairman Janvrin opened the meeting at 6:39PM with the Pledge of Allegiance.

Asking for a continuance until October 21<sup>st</sup> -Case 2024-11 – Proposal by Colliers Engineers on the behalf of Walmart for a site plan review at 700 Lafayette Road, Tax Map 8, Lot 55-100.

Janvrin stated that case 2024-11 will be continued to November 4<sup>th</sup>.

Case 2024-07- Proposal by Gen4 Builders, LLC for a 5-lot subdivision including a roadway at 111 Walton Road, Tax Map 10, Lot 106.

111 Walton Road is asking for a continuance to November 18<sup>th</sup> as they are going to TRC on November 12<sup>th</sup>. Abutter Nicole Letz, 112 Walton Road stated that they have been coming to the meetings, and they just keep getting continues and they are not satisfied. Janvrin stated that the applicant and engineer are meeting with TRC on November 12<sup>th</sup> and the planning board will be holding a meeting on November 25<sup>th</sup> instead of the 18<sup>th</sup>. He stated that this will be their last chance, and if they choose to continue again, they will need to resubmit their application.

## **Town Planner Rate**

Town Planner, Tom Morgan passed out a memo regarding a pay increase. Eaton stated that he would like to do some research regarding other pay rates in surrounding towns before making a vote. The board discussed and a majority of the board agreed with the pay increase.
