OTHER BUSINESS

- Tenant Issues:
 - O George Corde said there was a leak of some kind that damaged a ceiling tile in the Ground Swell rear kitchen area. He did not know the source of the leak. It could be a roof issue or it could have come from the drain vent next to the sink. Steve said he would talk to a plumber to determine the source of the leak. Ground Swell is closed for the winter.

o George also reported that the tenants wanted to reopen discussions on installing an awning outside the Ground Swell service window, improving outdoor lighting, snow plowing, front signage and painting a mural on the back of the building.

• Issues to bring up at the meeting with BoS.

- O Vicki Sawyer questioned the BoS position that they had no money for police patrols noting they just approved the purchase of a new gazebo for one of the parks in town. How can they afford to spend money on a gazebo and ignore public safety issues?
- o Ed David said parking placards are being copied and no tickets are being issued by the parking enforcement officer.
- o Is speeding on Rt. 1A a state or a town enforcement issue? Who receives the money collected from speeding tickets?
- Why doesn't the Town or State charge for parking on the north end of the Seabrook Harbor lot? It is used primarily by MA residents to avoid Hampton parking fees.
