Chairman Janvrin opened the meeting at 6:30PM with the pledge of allegiance.

**Case 2024-14 - Proposal by Chick-fil-A c/o Bohler Engineering for a site plan review at 712 Lafayette Road, Tax Map 8, Lot 55-10, asking for a continuance until February 3rd.**

The board continued the case to February 3<sup>rd</sup>, Morgan stated that he will send the board members the most recent letter from TEC regarding their comments.

**Route 286 Grant Application**

Morgan gave an update regarding the grant application and stated that everything is falling into place, but there is a minor issue regarding the date and miscommunication, and that the due February 24<sup>th</sup>. He stated that if this grant is successful VHB would do an analysis and create data to give us the best options regarding the evacuation of 286, and the cost. Morgan stated that Hampton doesn't have the staff currently to be on board, but Salisbury is on board and would like to be part of this. Lacey Fowler recommended to the board that they should reach out and meet or have Tom meet with the Beach Village District as this will affect them the most, the board agreed. Janvrin stated that VHB will need to start collecting data soon, and the town manager, Bill Manzi notified the department heads, and they stated they will cooperate with them. Janvrin stated that they should have another update on February 3<sup>rd</sup>.

**Meeting Dates**

Janvrin stated that the meeting dates in February will be Monday, February 3<sup>rd</sup> and Tuesday, February 18<sup>th</sup>.

**Warrant Articles**

Janvrin stated that someone needs to explain the three warrant articles at the deliberative session, and that there needs to be a motion to designate someone to explain those said articles.
