Chairman Janvrin opened the meeting at 6:30PM with the pledge of allegiance.

Case 2025-09 – Proposal by RT 1 Truck and Auto Sales for a conditional use permit for 894 Lafayette Road, Tax Map 7, Lot 93-2.

Nick Mancini, Tenant of Unit 10 at 894 Lafayette Road, was present at the meeting, he stated that he is asking for a conditional use permit to sell used vehicles, with no mechanical or auto body repairs at the location. Janvrin asked about the hours of operation, Mancini stated that the hours will be 8:30am-4:00pm Monday – Friday and 9:00am-12:00pm on Saturday. Janvrin asked how they are going to remove trash from the site, Mancini stated that he would use the common area dumpster, which would be everyday trash, no machinal or hazardous items. Janvrin said that they would need a variance for their sign if they wanted to have an offsite sign. Mancini stated that he would probably just put the sign on top of the roof as there is one there now. Janvrin stated that he would like to give him more hours of operation as in the summer he may be busier, Janvrin changed the hours to 8:00am-9:00pm Sunday-Saturday, and the business owner can use them as he sees fit throughout the year. Janvrin asked if one of the cars leaked, and how it would be cleaned up, Mancini stated that he would use the appropriate tools to clean up any spills. The board asked how many vehicles will be on the lot; Mancini stated about 7-8 vehicles.

If the current applicant is too close business and vacate, and similar business is to open at location, they shall abide by these conditions.

Driveway Regulations
