Chairman Stockbridge opened the meeting at 9:05AM.

WARRANT

Mrs. Stockbridge asked if they needed to have an article for sale of tax title of town property. Mr. Welch said it was already done so no article is needed.

Mr. Welch said the yes and no only goes on the ballot not the warrant for the deliberative session. He said a couple of articles have been moved.

Mr. McCann asked if article 6 needs a recommendation from the board. Mr. Welch said it is not required.

Mrs. Stockbridge said article 8 should be changed from "resident" to "residence".

Mr. Welch said article 9 is the budget committees article and does not need support from the board. He said by statute only the budget committee can put the article on the ballot.

Mrs. Stockbridge said article 12 should have a hyphen between less and costly. In article 15 supervisors needs an apostrophe.

Mr. McCann said article 18 should have impact on the tax rate.

Mrs. Stockbridge would like the money in articles 21, 22, 24, 28, 30 and 31 to be spelled out. Mr. McCann would like article 24 to be broken down to reflect the amount of money over the 3-year period. In article 24 raise should say raised. Article 31 has a typo se should be see.

Mrs. Stockbridge said the word "of" should be added to article 42. In article 43 timer should be timber and she would like accidentally to be changed to inadvertently. She said in article 44 court should be capitalized. In article 45 the word "the" should be removed. Article 47 has a typo, clas should be class. In article 48 "we" should say were.

Mr. McCann said in article 49 he would like to see the word cent in parenthesis.

Mrs. Stockbridge said in article 52 the word "if" should be "of" and the date on the last page should be January 29.

Mr. Welch said he has received a letter from Mr. McNeill regarding the petition submitted. The request is for the board to amend the petition article. There was general discussion on exactly what they were asking for. Mrs. Stockbridge said she does not feel good about the request. She said counsel has already given his advice. Mr. Welch said a minor textual change could be made and that would not include adopting a statute. Mr. McCann agrees it would not be a minor textual change and it is not within the timeframe to even consider. Board agreed to let the advice stand and let it go to the deliberative session as is.
