SELECTMEN'S MEETING APRIL 22, 2009

Chairman Kelly opened the meeting at 10:01AM.

PUBLIC HEARING - ANCHOR WAY

Mr. Kelly opened the public hearing at 10:02AM.

Mr. Brenner explained the planning board does recommend acceptance of Anchor Way and the road meets all Town standards.

Mr. Kelly closed the public hearing at 10:04AM.

MEETING - GRANT EXTENSION

Mr. Brenner explained that the Conservation Commission is working with NHDES for a grant on Cains Brook. There is a culvert with the brook and Route 1 and Route 1 is a state road. The infiltration is being repaired by the State so there would be changes to the dredge and fill application that has already been filed.

MONTHLY MEETING - FINANCE OFFICE MANAGER

Debra Knowles was present for her monthly report.

<u>2007 Audit</u> - is finalized and Cheryl Pratt will attend the meeting on May 6 to discuss.

<u>2008 Audit</u> - the office is working on the information for the audit that is scheduled for the week of June 8.

Debra Knowles left the meeting at 10:12AM.

MONTHLY MEETING - FIRE DEPARTMENT

Chief Jeff Brown was present for his monthly report.

Chief Brown said they are working on installing computer software, grants and reimbursement for the ice storm.

<u>Fire Permits</u> - there is a ban on the permits and has been for the entire month of April.

<u>Boat Classes</u> - are ongoing at the Fire Department and are done by the State.

Mr. Khan questioned the status of the ladder truck and how much money has been spent on maintenance. Chief Brown said it is a 1993 and in 2008 spent about \$32K just to pass the certification. He said it does need more repairs but not sure how much money it will cost. If it is too much money he is going to recommend it be put out of service. He said the use of the truck is not effective for commercial or apartment complexes. Chief Brown said he has a hard time asking the taxpayers to pay for a new truck when the truck would not be used for residential it would be used for commercial. The ladder truck is in the long-range capital improvement plan.

Mr. Kelly asked if the ambulance fund could be used. Chief Brown said no it is specific to ambulance fees only. Mr. Brenner explained that the revolving fund is established by the RSA and can only be used solely for ambulance fees. He explained the other ambulance fees that the fund could be used for.

John Kelley commented about the impact fees and it should be considered now as the new businesses come in to the Town. Mr. Khan said it has been looked at and the planning board did research and it was found that it was too late to establish. John Kelley said the Town is still building and with the economy it should be considered. Mr. Brenner said it is something that could be discussed with the Selectmen and the Planning Board.

Chief Jeff Brown left the meeting at 10:36AM.

MONTHLY MEETING - POLICE DEPARTMENT

Chief Pat Manthorn was present for his monthly report.

<u>Service Calls</u> - are still high. Car thefts and auto vehicle calls have increased.

<u>Uniforms</u> - new black shirts for the officers. The grey shirts were custom ordered and there is now only one place to order from.

<u>Stimulus Funds</u> - police department will receive \$39K as part of the stimulus package to update the server. The package will include a new operating system and platform.

<u>Intern Program</u> - with WHS has received positive feedback as they are seeing what the officers go through.

<u>Citizen of the Year</u> - was awarded to officer James Deshais and was justly deserved.

Renovations - Chief Manthorn is responding to questions raised at the April 16 budget meeting. He explained what the 2nd floor was used for. The only change was 3 doors being installed, which was done by Ray Hill and Don Chase. Chief Manthorn addressed the issues raised (see attached). He said all the work done was done on the employee's own time and there were minimal charges for the items. He said there is still construction needed for broken tiles, correct the floors, etc.

Mr. Moore asked about the control of the lights at the intersection where the new project is going. Chief Manthorn believes it would work and he explained how and why. He said the State needs to give them access to the boxes and if they do they would have control at the station. He said DDR would pay for and maintain through a Memorandum of Understanding.

Jeff Brown said his main concern is getting through the intersection at Route 1 and 107. If the cars were jammed in at the intersection as they are today the emergency vehicles would not be able to go anywhere.

Mr. Khan commented on the work that was done at the station and the employees willing to work on their own time. He is impressed with the way the department is being run.

Chief Pat Manthorn left the meeting at 11:11AM.

MEETING - SELECTMEN ABOUL B. KHAN

Mr. Khan read his statement on the economic situation (see attached). He said he would support all with the exception that no jobs were lost.

MOTION: Aboul B. Khan Second: Brendan Kelly

To have the Town Manager look into the ideas presented and make a recommendation to the Selectmen as soon as possible.

The Selectmen all agreed it is time to look at ways to save money without cutting jobs and services.

Mr. Brenner explained some of the financial concerns this fiscal year. The biggest challenge is coming from the Governor and legislature with the shared revenue that has been eliminated, which represents about \$80K to the Town. They also took away the rooms and meals tax but the house added this back into the budget. He said the Governor's budget also reduces the retirement cost from the State's share of 35% to 30%. The Town's cost would increase by about \$30K. He said until it is adopted by the legislature we do not know what to expect.

Mr. Brenner said the voters voted a default budget that is \$80K less than the proposed budget. He said it was a costly winter and the budget has already been expended for this line for 2009. The budget is also over-expended by \$20K in the salt line.

Mr. Brenner spoke about the cost of the Annual Town Report and some options to look at to save money.

Mr. Khan questioned the water department and the vehicles and how the department would run with the vehicles being out of service. Mr. Brenner explained both vehicles were taken of the road with no money to replace. He said he has worked it out with another department to transfer a vehicle to help out. He said the Town was very close to a deficit in 2008.
