**HUMAN SERVICE AGENCY - CHILD ADVOCACY CENTER**

Maureen Sullivan was present for the budget and explained the center. She said it is privately funded and they are the first to investigate a report of child abuse, whether it is physical and/or sexual abuse. She said they are called in by DCYF or the Police Department.

**TAX COLLECTOR - 150**

Lillian Knowles was present for her budget. She gave a brief overview of the tax office and what services they offer.

Mrs. Knowles said the postage has increased due to the semi-annual tax billing. This is usually shared with the water department, however they had to send out separate bills this year due to the water meters. The mileage and tolls increased due to the increase in fuel and she needs to attend 2 conferences in order to maintain her certification.

**TOWN CLERK - 140**

Bonnie Fowler was present for her budget. She stated the office would be open on Monday until 5PM for absentee ballots. The election is Tuesday, November 5 from 7AM - 7PM.

Mrs. Fowler explained the new services offered and the new office hours. She said a lot of people have commented on the new hours and she finds they are very happy with it.

It was explained that a new printer had to be purchased this year and was in the budget for next year. With this adjustment to the budget it has decreased by \$935.

**RECREATION CENTER - 460**

Sandy Beaudoin was present for her budget. She gave an overview of the department and the services offered.

Part-time employee line increased as they added classes/programs and also includes step-raises for current part-time employees.

On the new equipment line Ms. Beaudoin is looking to purchase a new phone system. They are currently on the old Merlin system, which is outdated and have been told they can no longer service the system.

Mr. Khan commented that they are looking for the taxpayers to raise \$720K for the facility. Mr. Kelly said it is a great facility with great programs and he supports it fully. Mr. Brenner said it could be something to look at in the future for fees charged. Mr. Khan said many people are concerned and not happy with the money spent on the recreation center. Ms. Beaudoin said they do have scholarships available for those who cannot afford the programs.

Mr. Brenner said Town Meeting vote authorized the replacement of the mini-bus with a transfer of surplus funds. This needs to show in the expenditure line and will increase this budget by \$10K.

Sandy Beaudoin was present for her budget. She went over the increases in the budget.

There was discussion on the increase in electricity and what affect the air conditioning will have on this budget.

Ms. Beaudoin described the new equipment she is looking to purchase.

Mr. Khan asked if there would be any costs for the new exit going at the Kohl's project. Ms. Beaudoin for now they would be fine.
