Mr. Hess opened the meeting at 10:12AM.

MONTHLY MEETING - POLICE CHIEF

Chief Lee Bitomske was present for his monthly report (see attached).

Chief Bitomske said Officer Michael Cawley is retiring after 20 years of service and congratulated him for his years of service.

Chief Bitomske said the radar trailers are out and most residents have seen them. They are working out the bugs with the system. He said statistics can be printed and provided to the Selectmen as needed. There was discussion on the number of cars that travel on Railroad Avenue. The average speed on this road is 31MPH.

Chief Bitomske provided an update on the dog situation from the meeting he attended with Senator Stiles, Mr. Manzi and Selectman Smith. His office has not received any complaints at this time with dogs being left out in the cold and said Jeff Baillargeon is monitoring the situation. He they could put something on channel 22 to educate the public.

Chief Bitomske said Officer Justin Murphy was commended by Salisbury Police due to a tragic incident he responded to. He deserves a lot of credit for what he did that day.

Mr. Khan asked about the drug overdoses in town and if there is any program they could adopt to help. Chief Bitomske said there really isn't anything. He said syringes are found all over town and there is nothing that can be done. He said people need to be educated but also need to be willing to accept help otherwise the programs won't work.

Chief Lee Bitomske left the meeting at 10:31AM.

MONTHLY MEETING - FIRE CHIEF

Chief William Edwards was present for his monthly report (see attached) also the Deputy Chief Lawrence Perkins was present.

Chief Edwards went over the two articles he would like to increase. He has an additional article he would like the Selectmen to consider placing on the warrant (see attached).

Mr. Khan asked who maintains the records on ambulance calls. Chief Edwards said he could contact 911 to see if they can give us numbers on how many calls were for potential overdoses. If he can get the number he will include in his monthly report numbers to the Selectmen.

Deputy chief Perkins said the appointment of the Fire Chief should be conducted by the NH Fire & Standards; which was enacted in 2001 when they voted to appoint a Fire Chief. He feels they used an illegal hiring practice and should conduct it by what the article states. Mr. Khan said they would look into this and will provide an explanation in written form to him. Deputy Chief Perkins said if the position needs to be reposed he suggests they consult with the fire department before posting.

Chief William Edwards left the meeting at 10:48AM.
