Chairman Kelly opened the meeting at 2:04PM.

Mr. Kelly said they had an issue at the last meeting and the nominations should have been dealt with at that meeting.

Mr. Khan said they need to fill the vacancy on the Board of Selectmen. Mr. Titone will get the certified copy of the official results from today's recount. The Board will be going into a non-meeting with Town Counsel.

Attorney Rob Ciandella explained the meeting laws under RSA 91-A:1 and how it works.

The Board recessed at 2:09PM. The Board reconvened at 2:27PM.

The Board explained the options they had to appoint someone to fill the vacancy and explained what each member opted for. Mr. Kelly said he will not vote for anything on this matter. Mr. Hess read the official certified results.

Mr. Titone read the statement by the Board of Selectmen to appoint Ray Smith.

Lacey Moore swore in the new Board of Selectman member Ray Smith. Mr. Smith took the seat as a member.

Maria Brown said in the past the Town Charter was challenged in a court of law and that challenge was not won. She said Mr. Kelly confirmed he was offered the position first and he declined unless Mr. Smith did not accept the position. Mr. Khan commented that Mr. Kelly was never offered the position that is his opinion only and that everything that was done by the Board of Selectmen last Friday was done legally. Maria Brown commented that the voters voted to not use the services of Donahue, Tucker & Ciandella but yet he is here.

Mr. Khan said he would like everyone to work together with the new member.
